It is moved:

1° to approve the Site Planning and Architectural Integration Program regarding the felling of 4 trees of 0.20 meter in diameter and over and the construction of a single-family dwelling with an isolated structure located at 552, Empire Street (lot 2 118 857), as per the report and plans presented

to the Planning Advisory Committee on June 16th, 2022, and amended at the request of the Planning Advisory Committee as follows:

- If additional trees must be cut during or following the construction, each of them must be replaced by new large-scale trees.
- 2° to require, as a prerequisite for the issuance of the building permit, a monetary guarantee in the amount of \$5,910.

The applicant must file their application for a permit and/or certificate of authorization within 24 months following the adoption of the present resolution, otherwise the resolution and the rights resulting from it become ineffective.
